WHEREAS, the institution Jayashanthi B.Ed. College, No. 258, Guruvareddiyur Main Road, Sanathikalmedu, P.K. Pudur Post, Bhavani Taluk, Erode, Tamilnadu-638504 was granted recognition vide SRC (NCTE) order no. F.SRO/NCTE/B.Ed./2006/8048 dated 26.09.2006 for conducting B.Ed. course of one year' duration with an annual intake of 100 students from the academic session 2006-2007.

- AND WHEREAS, on promulgation of NCTE Regulations, 2014, the institution has submitted affidavit dt. 09.02.2015 for its willingness of two units in B.Ed. course and adherence of provisions of new Regulations.
- 3. AND WHEREAS, provisional revised recognition order was issued to the institution on 30.04.2015 for conducting B.Ed. course of two years duration with an annual intake of 100 (two basic units) from the academic session 2015-16.
- AND WHEREAS, a general decision was taken by the SRC in its 314th meeting held on 27th & 28th May, 2016 to cause inspection of such institutions. A letter dt. 14.06.2016 was issued to the institution for causing inspection.
- AND WHEREAS, as per the decision of SRC, inspection of the institution was conducted on 18.10.2016. The inspection report received on dt. 21.10.2016.
- AND WHEREAS, the SRC in its 381st Meeting held on 31st & 01st November 2019 the matter was considered, and the Committee was decided to issued Final Show Cause Notice to the institution. Accordingly, as per directed a Final Show Cause Notice was issued on dt. 06.11.2019 to the institution. The institution submitted its reply along with documents on 26.11.2019 for compliance of Final Show Cause Notice dt. 06.11.2019.
- AND WHEREAS, the detail of documents / information submitted by the institution in compliance of Final Show Cause Notice on dt. 26.11.2019. The reply of the Final Show Cause Notice was placed before the SRC in its 386th meeting of SRC. The Committee considered the reply and decided to withdraw the recognition granted to the institution for running B.Ed course on the following grounds: -

"The Committee considered the Final Show Cause Notice's reply submitted by the institution on 17.12.2019 & 31.05.2019 and found the following deficiencies: -

- 1. As per the building plan the building is meant/used for school.
- 2. The size of Multipurpose Hall and Classrooms are less than the requirement of NCTE Regulations.
- 3. Latest faculty list as desired by the SRC has not been submitted.
- 4. Two Professors for M.Ed. have not been appointed.
- 5. Faculty strength for M.Ed. and B.Ed. course are not sufficient.
- 6. Proforma of faculty signed by the Registrar, TTEU has not been submitted.
- 7. Certified copies of Land documents with notarized English translation have not been submitted.
- 8. Website of institution is not updated."
- 8. AND WHEREAS, the institution has submitted a letter dt 10.08.20120 (P-1138/C) along with the documents. The institution vide letter dt 10.08.2020 stating as under:-

"With reference to the above, we would like to humbly submit before the SRC that our institution Jayashanthi B.Ed College is running only B.Ed college. Our institution is not having M.Ed course and we have not made any application for M.Ed course till date to SRC, NCTE.

Whereas, in the minutes of SRC in its 386th meeting has decided to withdraw the recognition to Jayasanthi B.Ed College and the deficiencies mentioned are pertaining to M.Ed course of some other institution. As we do not have M.Ed course, the deficiencies mentioned does not relate to our institution. The deficiencies mentioned in the minute are as under: -

- 1. As per the building plan the building is meant/used for school.
- 2. The size of Multipurpose Hall and Classrooms are less than the requirement of NCTE Regulations.
- 3. Latest faculty list as desired by the SRC has not been submitted.
- 4. Two Professors for M.Ed. have not been appointed.
- 5. Faculty strength for M.Ed. and B.Ed. course are not sufficient.
- 6. Proforma of faculty signed by the Registrar, TTEU has not been submitted.
- 7. Certified copies of Land documents with notarized English translation have not been submitted.
- 8. Website of institution is not updated."

The above deficiencies mentioned are not related to our Jayasanthi B.Ed Colelge.

Further, we would like to humbly submit that the we have submitted all the documents to SRC as per the requirements. Our institution has submitted the following documents in reply to Show Cause Notice......

9. AND WHEREAS, the SRC in its 387th meeting held on 24th – 25th August, 2020 considered the matter and decided as under;

The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made:-

On the perusal of the reply submitted by the institution vide letter dt. 10.08.2020, Committee decided that the continuation order be issued to the Institution Jayashanthi B.Ed College, No.258, Guruvareddiyur Main Road, Sanathikalmedu, P.K. Pudur Post, Guruvareddiyur -638504, Bhavani Taluk, Erode District, Tamilnadu for B.Ed programme for 2 basic units of 50 students each.

- 10. NOW THEREFORE, this order is issued permitting the institution i.e. Jayashanthi B.Ed College, RSF No.258/A, Sanathikal Medu, Kannapalli Village Panchayat, Ammapettai Union, Anthiyur Taluk, Erode District 638504 for continuation of recognition for B.Ed. course of two year duration with an intake of 100 students (two units) subject to fulfillment of the following conditions:
 - I. The Endowment fund of Rs. 5 lakhs and Reserve fund of Rs. 7 lakhs kept in joint account with Regional Director of NCTE should be maintained perpetually. Raising loan against the FDRs or mortgaging them shall not be done.
 - II. The institution shall comply with the various other norms and standards prescribed in the NCTE Regulations, 2014 as amended from time to time.
 - III. The institution shall make admissions only after it obtains affiliation from the examining body in terms of clause 8(10) of the NCTE (Recognition Norms & Procedure) Regulations, 2014.
 - IV. The institution shall ensure that the required number of academic staff duly approved by affiliating body for conducting the course should always remain in position.
- 11. Further, the institution is required to fulfill all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University/Body, the State Government etc as applicable.

- 12. The institution shall submit to the Regional Committee a Self Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a Chartered Accountant.
- 13. The institution shall maintain its Website with hyperlink to the Council and the Southern Regional Committee, covering, inter alia, the details of the institution, its locations, name of the programme(s) with intake; available of physical infrastructure, such as land, building, office, classrooms, and other facilities of amenities; instructional facilities, such as laboratory and laboratory and library and the particulars of their teaching faculty and non-teaching staff with photographs, for information of all concerned. The information with regard to the following shall also be made available on the website namely:
 - a. Sanctioned programme(s) along with annual intake in the institution:
 - b. Name of faculty and staff in full as mentioned in school certificate along with their qualifications, scale of pay and photograph.
 - c. Name of faculty members who left of joined during the last, quarter:
 - d. Name of Students admitted during the current session along with qualification, Percentage of marks in the qualifying examination and in the entrance test, if any, date of admission, etc.;
 - e. Fee charged from students;
 - f. Available infrastructural facilities;
 - g. Facilities added during the last quarter;
 - h. Number of books in the library, journals subscribed to and additions, if any, in the last quarter;
 - i. The affidavit with enclosure submitted along with application.
 - j. The institution shall be free to post additional relevant information, if it so desires.
 - k. Any false or incomplete information on website shall render the institution liable for withdrawal of recognition.
- 14. The institution shall adhere to the mandatory disclosure in the prescribed format and display up-to-date information on its official website.
- 15. The institution shall make available the list of students admitted on its official website.
- 16. The institution shall fill the information on GIS Portal on the NCTE Website.

If the institution contravenes any of the above conditions or the provision of the NCTE Act, Rules, Regulations and orders made of issued there under, the institution will render itself vulnerable to adverse action including withdrawal of recognition by the Southern Regional Committee under the provisional of Section 17(1) of the NCTE Act, 1993.

Also order that a copy of this Order be published in the official Gazette.
